*Students who are eligible to use FEE Help to assist with paying their fees should note that a 20% loan fee applies to undergraduate courses of study from 1 Jan 2022. In response to the COVID-19 pandemic, the federal government has announced an exemption to the loan fee for all units of study through 31/12/2021.
